The Issuer's "Hoteles Las Americas" hotels in Peru produced revenues of \$1,315,000 in June 2008. The Issuer's Eastbay Resort and Poro Point Casinos, where the Issuer controls 60% and 61% of the operations

respectively, generated revenue of \$3,573,000 for the month of June 2008; the Panama operations, of which the Issuer owns 61.36%, posted revenues of \$4,845,000; and in Costa Rica, of which the Issuer owns 50%, the operation generated revenues of \$2,653,000; during the month of June 2008 in Guatemala the operations generated revenue of \$444,000; in Nicaragua the three operating casinos of which the Issuer owns 54.6% generated \$1,095,000 in revenue.

2. Provide a general overview and discussion of the activities of management.

Management was pleased to commence operations at the Gran Plaza in Guatemala. Management continued its efforts in development in Colombia and in Poland. Our application to the Polish Ministry of Finance for approval of the acquisition of a controlling interest in this joint venture, which we refer to as Casino Centrum, was approved in June 2008. Management also completed its first draft of the application for filing on the Euronext. Operations in each country continue to meet and in certain cases, exceed management expectations.
